In accordance with Forest Stewardship Council (FSC) procedures the NZ Standard Development Group would like to invite all interested parties to register as members of the Consultative Forum.

By doing this, you can become a member of the Consultative Forum for the National Standard for Certification of Plantation Forest Management in New Zealand and contribute to the development of this document through formal comment.

The development of the National Standard for Certification of Plantation Forest Management in New Zealand in accordance with Forest Stewardship Council (FSC) procedures has recommenced. The standard is being revised by a Standard Development Group (SDG) comprised of representatives from four Chambers (Economic, Environment, Maori and Social).

The SDG re-commenced with the second Draft that had been at an impasse since November 2003 and have undertaken revisions in accordance with the Forest Stewardship Council (FSC) Process Requirements for the Development and Maintenance of Forest Stewardship Standards (FSC-STD-60-0006).

A revised draft has been forest tested through a simulated audit of Pan Pac Forests in Hawkes Bay. After which the SDG have made appropriate amendments to produce a Forest Tested Draft for consultation and are now, in accordance with FSC-STD-60-0006, forming a Consultative Forum as a mechanism to receive formal submissions on the Forest Tested Draft.

To be eligible for the Consultative Forum you must provide your full name, contact details and the capacity in which you are commenting. All other comments shall be considered as informal comments. Informal comments will only be responded to in so far as capacity allows.

All comments (formal or informal) should be attributed, and will be considered as being publicly available, unless the contributor explicitly requests that the comments should be treated confidentially. Anonymous comments shall not be considered.
